

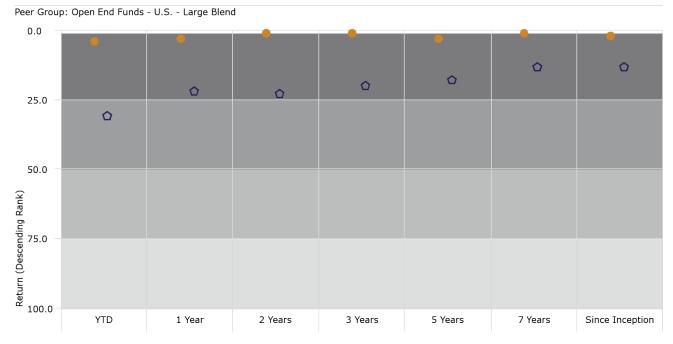
Q2-2025 Factsheet

The Legacy Bridge Large Cap Composite is a weighted average of the U.S. Large Cap component of 44 client portfolios. This composite is managed to our core equity process. We measure our returns to the Morningstar Open Ended U.S. Large Cap Blend peer group. This Morningstar class is currently comprised of 1,085 managers. Our process is to pursue consistent, above average returns relative to our peer group in all economic environments.
